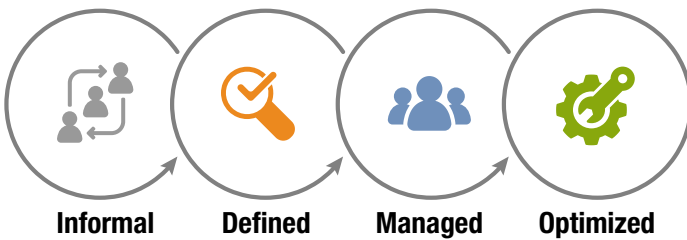
- **Approach** – Is the approach behaviorally sound? Are behavioral expectations clearly defined? Are the requirements simple or cumbersome and time-consuming?
